## 2025 -2026 Scrip Program Annual Agreement - PARISH

St. Thomas More (referred to herein as “we”, “us” and “our”) sponsors a scrip (or gift card) program which allows you to purchase Scrip. The Scrip you purchase through our program generates rebates from the participating retailers. The rebates are divided as 60% to you and 40% for STM School (or other allocation as selected below). (If you have a student in attendance at STM School, the rebate will be applied as a tuition credit for that family account and takes precedence.) The parties agree as follows:

Rebates earned will be used in the following way (choose one):

- a. \_\_\_\_\_ As tuition credit for our **STM Preschool family** (student \_\_\_\_\_)
- b. \_\_\_\_\_ As tuition credit for our **STM Grade School family** (student \_\_\_\_\_)
- c. \_\_\_\_\_ As tuition credit for **Another Family** at **STM Grade School** ( \_\_\_\_\_)
- d. \_\_\_\_\_ As tuition credit to **ACCHS** (student \_\_\_\_\_)
- e. \_\_\_\_\_ As tuition credit to **Notre Dame HS** (student \_\_\_\_\_)
- f. \_\_\_\_\_ As tuition credit to **Bethlehem Catholic** (student \_\_\_\_\_)
- g. \_\_\_\_\_ As a charitable donation to **STM School Scholarship Fund (potentially deductible)**
- h. \_\_\_\_\_ As a personal rebate check

Rebates are earned from July 1st to June 30th. Our Scrip program will distribute the rebates quarterly for STM School only. Tuition credits will be applied to the tuition at STM School (if applicable). All other rebates will be distributed annually in July.

A Shop with Scrip account will be set up for you. Your email address will be your username. When you log in for the first time, enter username and click “forgot password”. Follow the prompts to create your password.

You agree to indemnify us against any loss incurred in connection with there being insufficient funds in your account to cover the checks you issue to pay for your Scrip. We make no representations or warranties of any kind with respect to the Scrip. This agreement continues unless replaced by another, and can be terminated by either of us upon 60 day’s advance notice to the other.
